RATIONALE AND PURPOSE OF THE QUALIFICATION

RATIONALE:

The rationale of the Master of Arts in Politics and International Relations (MAPIR) is to provide students with multi-disciplinary graduate-level knowledge, specific skills, with strong graduate and research attributes that prepare them to be lifelong learners to compete in the global landscape. A Master of Arts in Politics and International Relations would appeal to traditional students who may wish to purse a doctorate in the area. Similarly, the qualification would offer courses on Foreign Policy, Foreign Policy Analysis, International Organization, Regional Integration, and Diplomacy and Statecraft, which are relevant to the Ministry of Foreign Affairs and International Cooperation, staff of various diplomatic missions in Botswana and embassies and



International Organizations. The qualification is innovative in that it blends key themes and trends in International Relations, and appeals to a broad spectrum of students, nationally and beyond.

In the new tertiary landscape and the aspirations of Vision 2036 (Botswana 2016; African Union (AU) Agenda 2063: The Africa We Want (AU, 2015); United Nations Sustainable Development Goals (UN, 2012); Southern African Development Community Regional Indicative Strategic Development Plan (RISDP), 2020-2030 (SADC: 22020); Southern African Development Community Vision 2050 (SADC: 2020) are indicative of being national, regional, continental, and global knowledge driven economy. In addition to the knowledge-based economy, SADC and AU, for example, aim to build peaceful, inclusive, and industrialized region through consolidation and institutionalization of principles enshrined in protocols such as Protocol on Politics, Defence, and Security (SADC: 2001); African Charter on Democracy, Elections, and Governance (AU: 2012) and African Charter on Human and Peoples' Rights (OAU: 1981). It is imperative to teach qualifications that are relevant and quality-enhanced, responsive to global political landscape and increase the attractiveness and competitiveness at the national, regional, continental, and global levels.

PURPOSE: (itemise exit level outcomes)

The purpose of the qualification Master of Arts in Politics and International Relations is to produce graduates with knowledge, skills, and competences to:

- Promote conciliation, mediation, and arbitration in international relations.
- Advance conflict resolution and management.
- Promote bilateral and multilateral diplomacies through mutual cooperation.
- · Foster normative principles of continental behaviour.
- Promote human rights and free and fair election.

MINIMUM ENTRY REQUIREMENTS (including access and inclusion)

The minimum requirement for admission into the Master of Arts in Politics and International Relations shall be:

- A bachelor's degree in social sciences at NCQF level 7 with at least a second-class division or equivalent from a recognized university.
- *ii)* Relevant prior learning, work experience, and transfer of credits from comparable institutions in areas covered by the qualification will be recognized but will not outweigh formal academic



qualifications. In addition, relevant experience in the areas of governance, defence and security management will be recognized.

ASSESSMENT ARRANGEMENTS

Formative assessment: The contribution of formative assessment to the final grade shall be 50%.

Summative assessment: This will constitute 50% of the final mark.

QUALIFICATION AWARD AND CERTIFICATION

Minimum standards of achievement for the award of the qualification

A student shall be eligible for the award of a Master of Arts Degree in Politics and International Relations (MAPIR) upon completion of a minimum of 240 credits from the fundamental, Core and electives.

Certification

Candidates meeting prescribed requirements will be awarded a Master of Arts in Politics and International Relations in accordance with standards prescribed for the award of the qualification and applicable policies. Candidates who do not meet the prescribed minimum standards may, where applicable, be considered for appropriate exit awards in accordance with applicable policies.

SUMMARY OF REGIONAL AND INTERNATIONAL COMPARABILITY

To ensure comparability with similar degree qualifications, the Master of Arts in Politics and International Relations qualification was developed through a conscientious benchmarking exercise. Prior exploratory research and internet search were conducted to identify universities and institutes in the region, continent of

Africa and globally that offer similar degree qualifications.

Comparability with Regional Universities

One university in the region was selected to compare it qualification structure with the proposed qualification and to learn from them. The selected University is:

• University of Witwatersrand, South Africa: Master of Arts in (International Relations)

Comparability with International Universities

The Master of Arts in Politics and International Relations (MAPIR) qualification was benchmarked with one reputable international university in Europe. It was chosen because it is top ranked university, and it is among the very few universities outside of Africa that focus on international relations at the postgraduate level.

Master of Science in International Relations, London School of Economics, UK

Similarities

• In respect of some of the applicable standards and rules for the award of the master's degree, both universities require good honour's degree in a relevant field. All qualifications entail some research aspect and there are several modules that are the same; for example, modules related to international relations and conflicts aversion.

Differences

• The main difference is in the method of delivery. The qualifications benchmarked offer both full-time and part- time options for studying. There are also differences in some of the modules offered.
